NOTICE OF ANNUAL GENERAL MEETING OF IDEAGEN PLC

Enclosed with this letter is a notice of the Annual General Meeting of the Company to be held at the offices of finnCap, 60 New Broad Street, London, EC2M 1JJ at 12 noon on Tuesday 30th October 2019.

The enclosed notice of Annual General Meeting ("AGM") includes resolutions for the following:

1. to receive and adopt the Annual Report and Accounts for the year ended 30th April 2019 (a copy of which is enclosed with this letter);
2. to approve the re-appointment of Ben Dorks as a director of the Company;
3. to approve the re-appointment of Graeme Spenceley as a director of the Company;
4. to approve the re-appointment of RSM UK Audit LLP as auditor of the Company at a fee to be agreed with the Directors;
5. to approve the payment of a final dividend of 0.188 pence per share in respect of the year ended 30th April 2019;
6. to renew the general allotment authority of the Directors to enable them to allot relevant securities, being up to 73,606,114 ordinary shares in the capital of the Company, representing approximately one third of the issued ordinary share capital of the Company on 23rd September 2019;
7. to renew the disapplication of allotment authority given to the Directors to enable the Directors to dis-apply the statutory rights of pre-emption in relation to the allotment of equity securities, such authority limited to 22,081,834 ordinary shares in the capital of the Company, representing approximately 10 per cent. of the issued ordinary share capital of the Company on 23rd September 2019.

Note on appointment of directors

In accordance with the Company's articles of association, Ben Dorks and Alan Graeme Spenceley are retiring by rotation and, being eligible, are both seeking re-appointment as directors under resolutions 2 and 3.

Form of proxy

A form of proxy for use by shareholders at the Annual General Meeting is enclosed. Whether or not you propose to attend the Annual General Meeting, you are requested to complete and sign the form of proxy in accordance with the instructions printed thereon and return it to the Company's registrars, SLC Registrars at Elder House, St Georges Business Park, Brooklands Road, Weybridge, Surrey KT13 0TS, as soon as possible and in any event so as to be received no later than 12 noon on Monday 28th October 2019 (London (UK) Time). The completion and return of a form of proxy will not preclude you from attending the Annual General Meeting, speaking and voting in person should you wish to do so.

Recommendation

The Board believes that the proposals in Resolutions 1 to 7 are in the best interests of the Company and its Shareholders as a whole. Accordingly, the Directors (excluding Ben Dorks for the purposes of Resolution 2 and Graeme Spenceley for the purposes of Resolution 3) recommend that Shareholders vote in favour of each Resolution, as they intend to do so in respect of their own beneficial shareholdings.

NOTICE OF ANNUAL GENERAL MEETING

NOTICE IS HEREBY GIVEN THAT an Annual General Meeting of the shareholders of the Company will be held at the offices of finnCap, 60 New Broad Street, London EC2M 1JJ on Wednesday 30th October 2019 at 12 noon to consider and if deemed fit to approve the following resolutions:

ORDINARY RESOLUTIONS

1. TO receive and adopt the Annual Report and Accounts for the year ended 30th April 2019.
2. TO re-appoint Ben Dorks as a director of the Company.
3. TO re-appoint Graeme Spenceley as a director of the Company.
4. TO re-appoint RSM UK Audit LLP, as auditor of the Company until the next general meeting at which financial statements are laid before the Company, at a fee to be agreed with the board of Directors.
5. TO approve the payment of a final ordinary dividend of 0.188 pence per share in respect of the year ended 30th April 2019. If approved the final dividend would be paid on 26th November 2019 to shareholders on the register on 8th November 2019.
6. THAT the Directors be and are hereby generally and unconditionally authorised for the purposes of section 551 of the Companies Act 2006 ("the Act"), to exercise all the powers of the Company to allot shares in the Company and to grant rights to subscribe for, or to convert any securities into, shares in the Company, provided that such authority shall be limited to the allotment of Ordinary Shares of £0.01 each in the capital of the Company ("Ordinary Shares") or the grant of rights to subscribe for or to convert any securities into Ordinary Shares up to an aggregate nominal amount of £736,061.14 (the equivalent of up to 73,606,114 Ordinary Shares, representing approximately one third of the issued ordinary share capital of the Company on 23rd September 2019), this authority to expire on the earlier of fifteen months from the date of the passing of this resolution or the conclusion of the Annual General Meeting of the Company to be held in 2020 unless previously renewed, varied or revoked by the Company in general meeting, save that the Company may before such expiry make any offer or agreement which would or might require shares in the Company to be allotted or rights to subscribe for or to convert any securities into shares in the Company to be granted after such expiry and the Directors may allot shares in the Company, or grant rights to subscribe for or to convert any securities into shares in the Company, in pursuance of any such offer or agreement as if the authority conferred hereby had not expired.

SPECIAL RESOLUTION

7. THAT, subject to the passing of Resolution 6 above, the Directors be and are hereby unconditionally empowered pursuant to sections 570 and 571 of the Act to allot equity securities (as defined in section 560 of the Act) pursuant to the authority granted to the Directors pursuant to Resolution 6 above as if section 561 of the Act did not apply to any such allotment, provided that this power shall be limited to:
 - 7.1 the allotment of equity securities in connection with a rights issue, open offer or equivalent offer in favour of the holders of Ordinary Shares and such other equity securities of the Company as the Directors may determine in which such holders are offered the right to participate in proportion (as nearly as may be) to their respective holdings of such equity securities or in accordance with the rights attached thereto but subject to such exclusions or other arrangements as the Directors may consider necessary or expedient in connection with shares representing fractional entitlements or on account of either legal or practical problems arising in connection with the laws of any territory, or of the requirements of any recognised regulatory body or stock exchange in any territory;
 - 7.2 other than pursuant to sub-paragraph 7.1 above, the allotment of equity securities up to an aggregate nominal amount of £220,818.34 (the equivalent of up to 22,081,834 Ordinary Shares, representing approximately 10 per cent. of the issued ordinary share capital of the Company on 23rd September 2019); and this power shall expire on the earlier of fifteen months from the date of passing of this resolution and upon the conclusion of the Annual General Meeting of the Company to be held in 2020 unless previously renewed, varied or revoked by the Company in general meeting, save that the Company may before such expiry make any offer or agreement which would or might require equity securities to be allotted after such expiry and the Directors may allot equity securities in pursuance of any such offer or agreement as if the power conferred hereby had not expired.

Changes to entries on the Register of Members after that time shall be disregarded in determining the rights of any person to attend and vote at the meeting.
5. The completion and return of this form will not preclude a member from attending the meeting and voting in person. If you attend the meeting in person, your proxy appointment will be automatically terminated.
6. To be effective, all votes must be lodged by no later than 12 noon on Monday 28th October 2019 at the office of the Company's registrars at SLC Registrars, Elder House, St Georges Business Park, Brooklands Road, Weybridge, Surrey KT13 0TS.
7. In the case of joint holders, where more than one of the joint holders purports to appoint a proxy, only the appointment submitted by the most senior holder will be accepted. Seniority is determined by the order in which the names of joint holders appear in the Company's register of members in respect of the joint holding (the first-named being the most senior).
8. In the case of a member which is a company, this form must be executed under its common seal or signed on its behalf by an officer of the company or an attorney for the company. Any power of attorney or any other authority under which this form is signed (or a duly certified copy of such power or authority) must be included with the proxy form.
9. Unless otherwise indicated the proxy will vote as they think fit or, at their discretion, abstain from voting.
10. Copies of the Executive Directors' contracts of service and copies of the Non-executive Directors' letters of appointment will be available for inspection at the Company's registered office during normal business hours on any weekday (Saturdays, Sundays and English public holidays excluded) from the date of this notice of the Annual General Meeting until the date of the Annual General Meeting and at the place of the meeting at least 15 minutes prior to the commencement of the Annual General Meeting until its conclusion.
